

- Half a decade on and only 5 years to go!
 - Forums 2019/20
 - WR priorities for landlords

Universal Credit Aims

- Encourage more people into work by introducing better financial incentives, simpler processes and increasing requirements on claimants to search for jobs;
- Reduce fraud and error; and
- Reduce the costs of administering benefits
- Current timeline 2010 – 2023 = 13yrs...!

Universal Credit Reminder from the National Audit Office!

“Both we, and the Department, doubt it will ever be possible for the Department to measure whether the economic goal of increasing employment has been achieved. This, the extended timescales and the cost of running Universal Credit compared to the benefits it replaces cause us to conclude that the project is not value for money now, and that its future value for money is unproven.”

Rolling Out Universal Credit: DWP, National Audit Office Report, June 2018

NAO Recommendations on UC: June 2018

1. Improve tracking and transparency of UC progress towards its intended benefits
2. Ensure operational performance & costs improve sustainably before increasing caseloads through managed migration
3. Work with delivery partners to establish shared evidence base for how UC working in practice
4. Make it easier for third parties to support claimants i.e. portal, consent, journal access
